Critical Facilities - This dataset was created through several efforts. Many of these points were identified during the emergency planning process with local input by where available. The NH Broadband Mapping and Planning Project also contributed data to this dataset.

Water and Sewer Service Areas were provided by the NH Department of Environmental Services. These areas are approximate and were derived from buffering road centerline features by a constant distance for streets having water, sewer or both services available.

Base Features (transportation, political and hydrographic) were automated from the USGS Digital Line Graph data, 1:24,000, as archived in the GRANIT database at Complex Systems Research Center, Institute for the Study of Earth, Oceans and Space, University of New Hampshire, Durham, NH; 1992-2012. The roads within the Rockingham Planning Region have been updated by NH Department of Transportation through local input by the RPC where available.
