These facilities were nominated by community representatives in the interest of preserving cultural, natural and historic resources. Collection of this information was sponsored by the NH Department of Environmental Services under the Regional Environmental Planning Program and was initiated in 1997. These features were mapped by RPC as point locations on a 1:24,000 scale base map. Each location has been labeled with a unique code, which relates to an attribute table, available separately from RPC. This information was last updated in June 2004. **NH Historic Highway Markers**The RPC downloaded the KML of NH highway markers from NH Division of Historical Resources, and converted this data into GIS format. This was last updated in June 2014. **NH Register of Historic Places**The RPC extracted the data about places that have been listed in the NH Register of Historic Places from the

The RPC extracted the data about places that have been listed in the NH Register of Historic Places from the NH Division of Historical Resources website. This data was converted into a spreadsheet and subsequently into GIS. This data is current to June 2014.

National Register of Historic Places

The RPC obtained data from the National Register of Historic Places. The RPC located the NH locations and created a GIS dataset from the point data. This data is current as of June 2014.

Base Features (transportation, political and hydrographic) were automated from the USGS Digital Line Graph data, 1:24,000, as archived in the GRANIT database at Complex Systems Research Center, Institute for the Study of Earth, Oceans and Space, University of New Hampshire, Durham, NH; 1992-2012. The roads within the Rockingham Planning Region have been updated by NH Department of Transportation through local input by the RPC where available.
