### **TIP Amendment Process**

- Amendments occur quarterly
- Address "substantial" changes to project scope, schedule, and cost
- 1. NHDOT provides draft Amendment that is reviewed and endorsed through the Interagency Consultation Process
- 2. Proposed Amendment is processed by staff into the MPO TIP Revision Database
- 3. Required 10-30 day public comment period is started and timed to end the day prior to the MPO Policy Committee meeting
- 4. Transportation Advisory Committee (TAC) reviews changes and makes a recommendation to the MPO Policy Committee
- 5. MPO Policy Committee approves the Amendment after the end of comment period, a public hearing, and discussion.

- 76 Regional Projects
- 4 Statewide projects for RPC to consider
- A Public Comment Period will begin on July 1, 2021 and concluded on July 12, 2021.
  - Comment from City of Portsmouth/NHDOT to add changes to Portsmouth 42350
- Net funding change in TIP: +\$29,894,174
- Net funding change in LRTP: +\$50,063,762

### Fiscal Constraint & Air Quality

- Air Quality Conformity is not needed as we have been in Attainment since 2013 and can rely on previous analysis
- Fiscal Constraint is maintained.
  - Portsmouth 42350 utilizes \$507,245 of unprogrammed Highway Safety Improvement Program (HSIP) funds for the additional funding. There remains a net balance of HSIP funds available in FY21.
