2023-2026 Transportation Improvement program (TIP) & 2045 Long Range Transportation Plan

- 30 Day Public Comment Period began on January 6, 2023 and will conclude on February 7, 2023
- Public Hearing on February 8, 2023 at the MPO meeting
- Once all MPO TIPs are approved the State TIP (STIP) is submitted for Federal approval
- MPO TIP & LRTP must be *consistent* in that TIP projects must be shown with similar cost and timing in the LRTP.

Regional Projects

The funding allocated to regional projects included in the TIP for implementation is summarized in *Figure 7-3* and each of the projects are listed individually in *Figure 7-4*. Projects are sorted by community/location and project numbers and represent all projects that are either federally funded or are considered regionally significant and thus require federal action as part of the TIP approval. Figure 7-4 includes all individually listed projects in the region with the exception of the FTA funding for the regional transit agencies. Each of these agencies (CART, COAST, and UNH Wildcat Transit) show a single project for each of their FTA funding allocations. Further details on the transit projects are include in in Section 7.4 and the accompanying figures. The project details incorporated into Figure 7-4 include project name and number, location, general scope, programmed cost by phase and year inflated to year of construction costs for each of that may be project are also shown and this includes costs accrued for the years before and that may be programmed after the TIP timeframe.

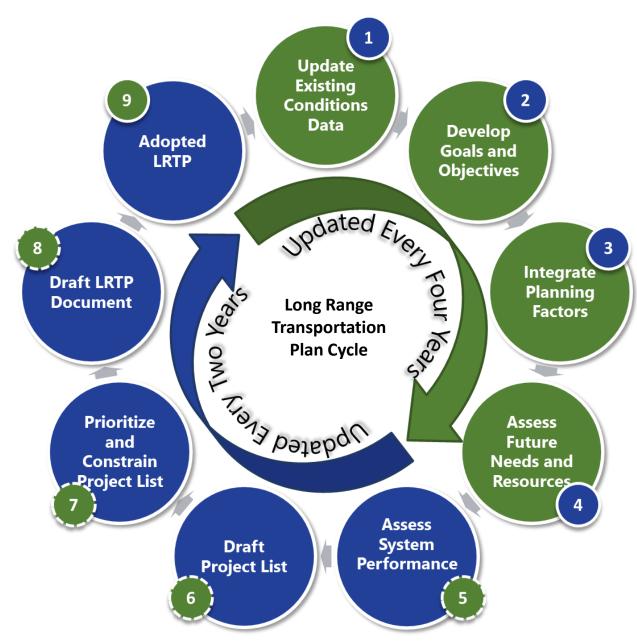

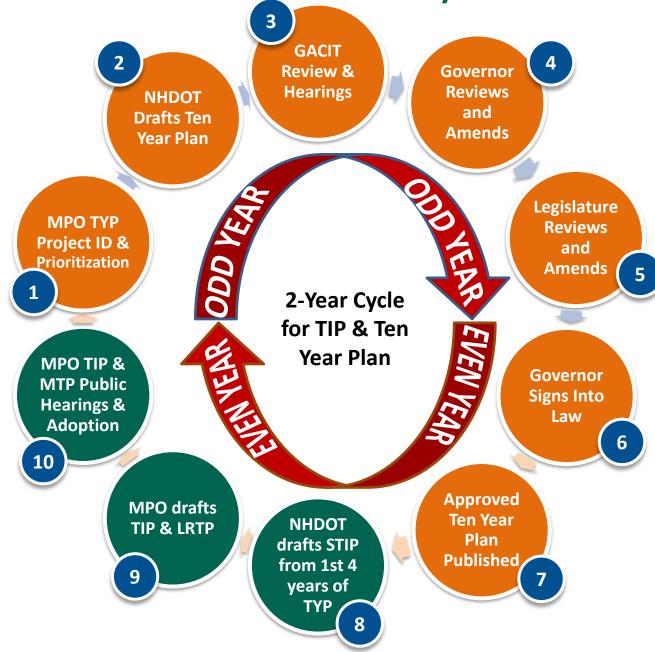
LRTP Process

- LRTP provides initial list of projects for the Ten Year Plan
- Prioritization process determines when a project is "scheduled" in the LRTP



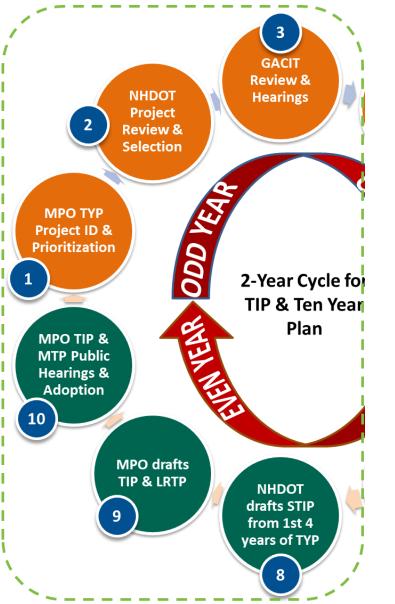
Ten Year Plan & STIP/TIP Process



- 2-Year Cycle
- MPO involved at beginning and end of process
- Governor Signing Ten Year Plan starts STIP development
- DOT builds STIP from first 4 years of Ten Year Plan and ongoing projects
- MPO builds TIP from Draft STIP released by NHDOT



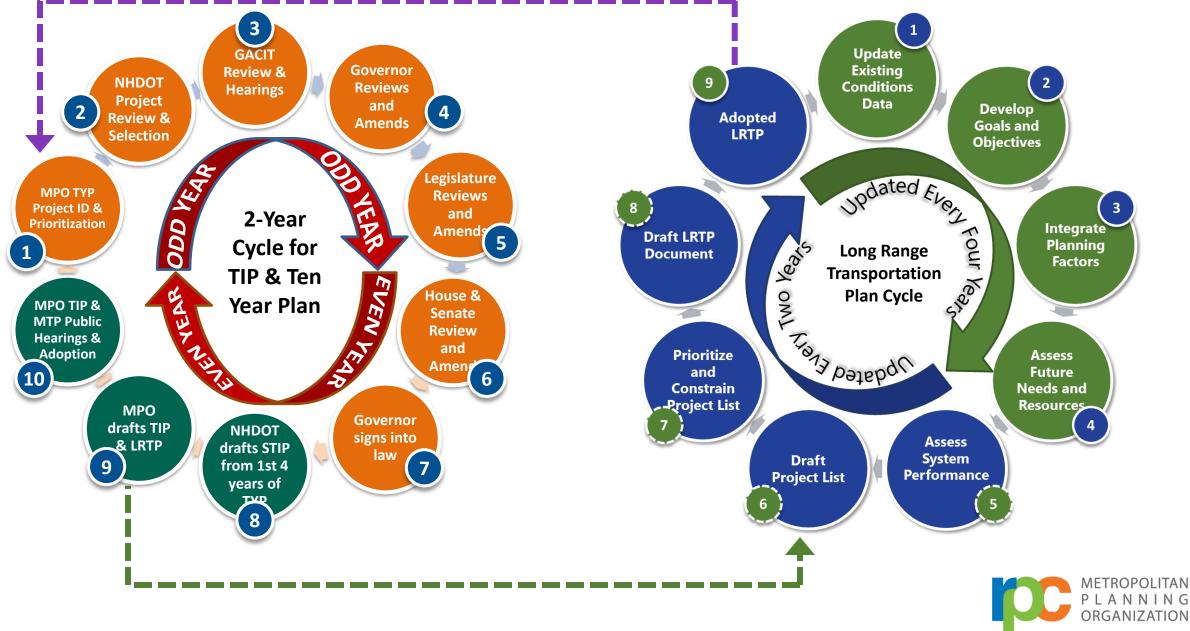
MPO ROLE IN THE STATE TEN YEAR PLAN

- 3. Provide Input to GACIT (District 3) on the contents of the draft Ten Year Plan. Present MPO Planning Process and Priorities at public hearings.
- 8. Review draft STIP and provide feedback to NHDOT regarding projects included (or not)
- 9. Draft Regional TIP and update Long Range Plan project listing based on approved TYP contents
- **10.** Approve new 4-year TIP and updated LRTP

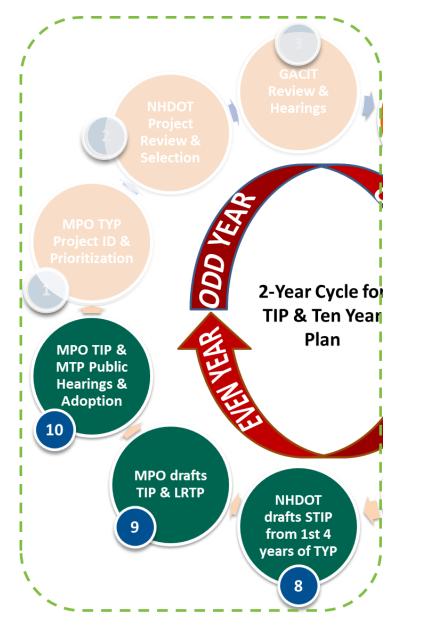

- Incorporates information on ongoing projects
- Adds new projects for two outer years (2025-2026)
- Becomes first four years of Long Range Transportation Plan
- More stringent fiscal constraint requirements than the Ten Year Plan

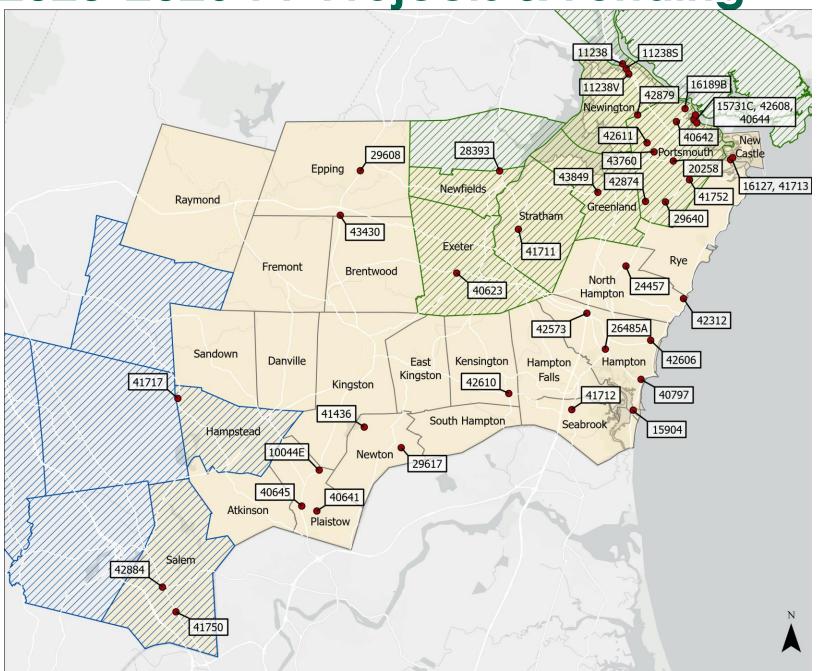

Changes to Address

- 10 Views of public engagement portal but no comments received.
- COAST noted that the recently awarded FTA 5339(b) grant for the construction of a maintenance facility needs to be added to the TIP. This includes \$7,736,284 in new Federal funds.
- COAST also received an additional \$2,000,000 in USDOT Transit Infrastructure bond funding that will need to be incorporated as well. Possibly a separate project.
- Portsmouth has requested that funding for Portsmouth 40642 (Maplewood Ave Complete Streets) be shifted to Portsmouth 20258 (Peverly Hill Road bicycle and pedestrian improvements). The work proposed for Maplewood Ave has been completed using other funds.
- Working on completing the System Performance Report.
- Continuing to review project list and financials to ensure accuracy and consistency with NHDOT
- Continuing to address technical edits to the document

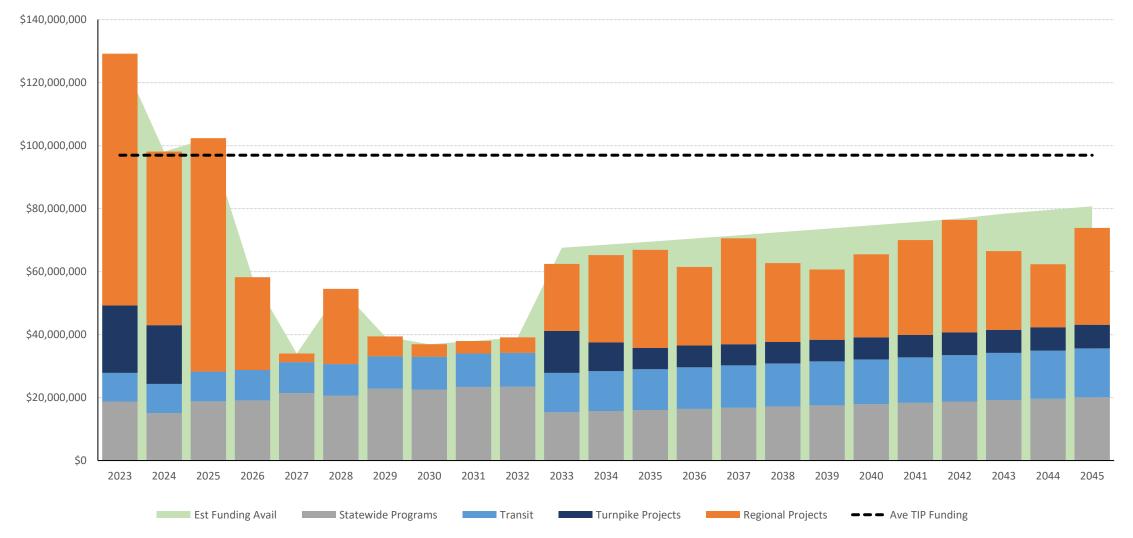

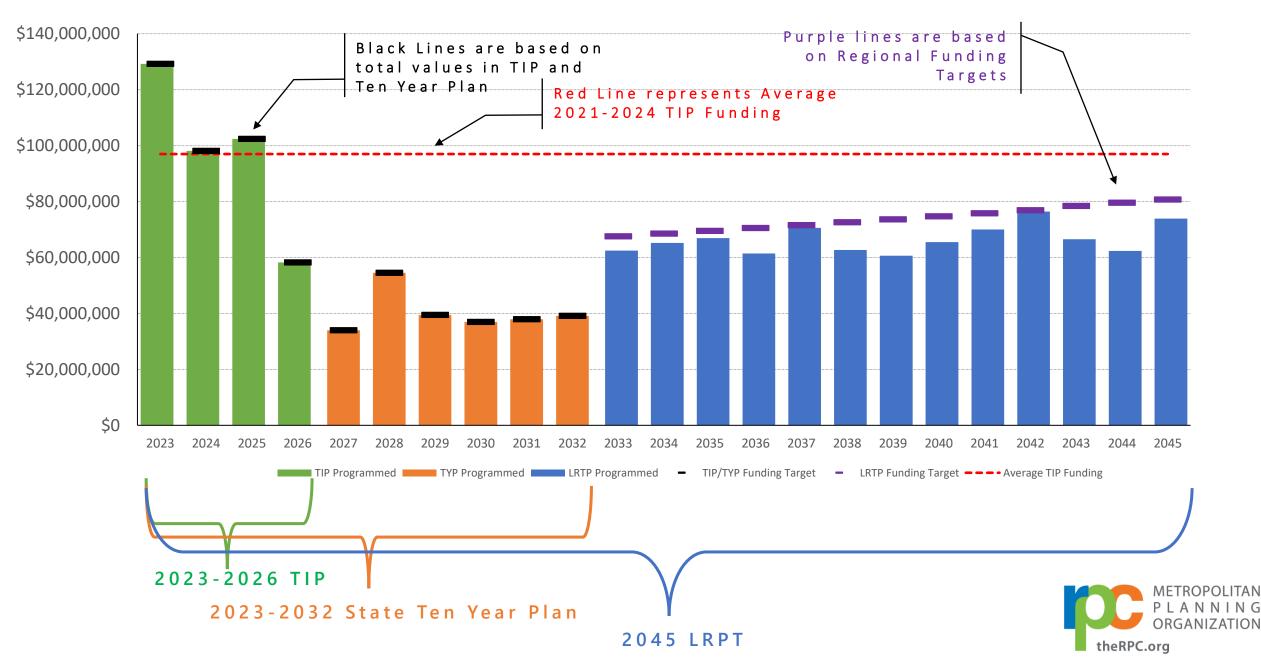
Fiscal Constraint Assumptions

- Estimate of Revenues from NH DOT based on agreed to methodology (consistent among MPOs)
- Funds in the STIP/TIP & Ten Year Plan equal the regional share for those years (2023-2032)
- Beyond the Ten Year Plan, the RPC "share" of revenues is 22.5% of Turnpike maintenance funds and 13.3% of all other resources.
- Costs inflated at 2.8% per year
