### Parking

There is **two hour on-street parking** along Water Street and Center Street. There is also parking in the small lot on Center Street, by the Citizens Bank Drive-thru (Non-numbered spaces), and in the municipal lot behind the Town Offices. Handicapped parking spaces are available on the bottom floor of the parking structure adjacent to the RPC office as well as on Water Street in front of the RPC office. In addition, RPC has 6 spaces on the upper deck of the parking garage (accessible by the bank drive-thru on Front Street) that may be available. Access those spaces by entering past the drive-thru and they are those to the immediate left that stick out further than the remainder of the lot. The yellow circle near the center of the map shows where those spots are located.
